KUULUSTELUKERTOMUS

Georgian oikeusministeriön pääprokuraattoriviraston oikeusapupyynnön 15-04295 mukaisesti vrk Porola oli puhelimitse yhteydessä Vissarion Gougoushviliin 21.10.2015.

Gougoushviliille kerrottiin pyydetyistä todistajakuulusteluista ja sovitusti lähetettiin virallinen kutsu saapua kuulusteluun sähköpostitse Gougoushviliin antamaan sähköpostiosoitteeseen 21.10.2015 klo 10:32 ja erikseen Gougoushviliin kotiosoitteeseen lähetettiin kirjallinen kutsu.

Rikoskomisario Olli Töyräksen päätöksellä Gougoushviliille toimitettiin postitse oikeusapupyynnössä annetut kysymykset. (Kuulustelun Liite 3)

Vissarion Gougoushvili vastasi sähköpostitse 21.10.2015 klo 13.08 (Kuulustelun Liite 1.)

Vissarion Gougoushvili lähetti sähköpostitse lisävastauksen 22.10.2015 klo 22.57 (Kuulustelun Liite 2)

Rikoskomisario Olli Töyräksen päätöksellä Vissarion Gougoushviliin kuulustelu suoritetaan sähköpostitse, Suomen esitutkintalain 7 Luku 1§ perusteella.

According to Finnish law, the witness hearing is possible to make by email. I have already sent you the questions made by Georgian considering the investigation of Mr Zviad Gamsakhurdia's murder (see attached "kysymykset"). You have kindly sent me in 22.10.2015 the email, where you gave an answer for that matter, (see attached copy of your " answer".)

As a witness you have also been given the Information for the witness document, where is mentioned " Obligation to be truthful and give evidence", "Avoiding self-incrimination" and "More information about your obligations and rights". (see attached "information for witness")

There is also known that you are political asylum here in Finland.

The final questions, I will make you by now is:

1. Are you going to give a witness statement the Georgian Office of Chief prosecutor asked for?
2. If you don't want to testify, what are your grounds?
3. Will you give the permission to use your "answer" in the witness hearing and sent it to Georgia?

To Madame Susanna Porola

My answers on your last questions (23.11.2015) are:

1) I am not going to give a witness statement the Georgian Office of Chief prosecutor asked for

2) Grounds I don't want to testify - is following: (and I give you permission for using them ("grounds") as a part of witness hearing and for sending them to Georgia together with "answer"):

1.

Present regime of Georgia was (and is) enemy side for Government of Georgia of Z.Gamsakhurdia in Georgian Civil War which has started in 1991. There was no any peace agreement or capitulation signed by Government of Z.Gamsakhurdia with other side of Civil War. Till today I represent Government of Georgia of Z.Gamsakhurdia — as there does not exist any legal document of my resignation. For me, a regime ruling Georgia today is enemy side and is not legal/legitimate. I have not and would not have any contacts and relations with illegal regime of Georgia and with any of its structures — I am in exile in Finland (having political asylum) and from the point of legality till now I am Prime Minister of Georgia.

2.

More and especially — as eyewitness of suicide of Z.Gamsakhurdia I will not take participation in any investigation which is classified as murder!

3.

I will not take participation in this investigation because the Georgian regime has signed agreement by Vice Prime Minister A.Margiani (16 Feb. 1994) where is specially mentioned that:

“3. Witnesses of death of Z.Gamsakhurdia would not participate in any kind of investigation”. I demand from Georgian side to respect their own obligations.

4.

I will not take participation in this investigation because contrary to permanent requests from eyewitnesses of suicide of Z.Gamsakhurdia starting immediately after his death time:

4.a) Not in Georgia (1994) or in Chechnya (1994), nor in Georgia (2007) was done any Forensic-medical examination of body of Z.Gamsakhurdia.



4.b) Was not done immediate detailed, objective and honest investigation of suicide of Z.Gamsakhurdia (death scene, etc.) by neutral, independent organization.

4.c) All "investigations" of death of Z.Gamsakhurdia including "investigation" done by Parliamentary commission headed by son of Z.Gamsakhurdia (2010) were and are politically motivated, not honest and not objective.

4.d) Of massive defamation hysteria, especially active since 2004, managed and stimulated by illegal regimes of Georgia in mass media, accusing eye-witnesses in murder and/or in aiding murders.

5.

During past 20 years I have published dozens of memoirs and interviews, released special book where I have answered, explained all and any serious, important, valuable questions about/relating the death of Z.Gamsakhurdia. In 2004 there was 2 hour interview with me on most popular TV show, when all valuable aspects of the suicide of Z.Gamsakhurdia were discussed.

6.

After detailed studying and analyzing Questions sent by prosecutors of illegal regime of Georgia, I have found, discovered that MOST of questions are linked, connected, associated with "Case #7492801/#7493846 against Z.Gamsakhurdia, V.Gougouchvili, N.Burchuladze and others" in which I am figured as suspect, criminal and which is not closed! Such questions are collecting valuable, sensitive information for Case #7492801 / #7493846 — about members of legal Government and subordinates (including officers of armed structures and secret agents); structures of legal Government (including secret links, secret lines of communications, management systems, private relations, etc.); actions of legal Government (including military and secret operations, etc.); foreign links of legal Government; etc.; etc... Actually and factually planned Questioning includes covered, hidden questioning for "Case #7492801/#7493846 against Z.Gamsakhurdia, V.Gougouchvili, N.Burchuladze and others". Having obtained from me such a valuable information, prosecutors of illegal regime of Georgia can restart paused investigation on "Case #7492801/#7493846 against Z.Gamsakhurdia, V.Gougouchvili, N.Burchuladze and others" as they restarted investigation on "Case # 7494802, aggravated murder of Z.Gamsakhurdia" after 20 years !!!

I have to remind you and your Bureau, that, I have asked and was granted political asylum in Finland mainly because of persecution in Georgia, based on "Case #7492801/#7493846 against Z.Gamsakhurdia, V.Gougouchvili, N.Burchuladze and others".

7.

"Investigation" of Mr. Zviad Gamsakhurdia's "murder" by illegal regime of Georgia is politically motivated; Investigators are not truthful and free in



theirs judgments, they have not enough qualification and knowledge and are well known as corrupted. Without any serious evidences, witnesses and well established facts — suicide of Z.Gamsakhurdia was classified as murder based only on political will of ruling illegal regime.

3) I give the permission to use my "answer" (and "grounds") in the witness hearing and sent it to Georgia
